






## MANUAL OPERATING INSTRUCTIONS

**ON** - Continuous illumination until manually turned off.

**TIMER** - Continuous cycle of 6 hours on followed by 18 hours off beginning daily at inital set time.

**OFF** - No illumination/Timer cycle off.



## REMOTE CONTROL OPERATING INSTRUCTIONS

NOTE: To use Remote (B), Candle Switch must be moved to ON and remain in that position.

**ON/OFF** - Illumination on or off.

**TIMER** - 2 hours/4 hours/6 hours/8 hours. Activates automatic illumination timed duration cycle beginning daily at time initially set.

**MODE**: Flickering or Steady illumination **DIMMER**: Illumination brightness high/low.
